

**TECHNICAL SPECIFICATION FOR THE PUBLIC PROCUREMENT OF PASSENGER
CAR LEASE SERVICES**

The Permanent Representation of Lithuania to the European Union (hereinafter referred to as the Contracting Authority) intends to lease 1 (one) new passenger car for representative and business purposes (hereinafter referred to as the car). The operating lease period is 36 months. The maximum permissible mileage for the entire lease period is 75,000 km.

Requirements for the vehicle:

1.	Car class, body type (according to the requirements for the categories and classes of motor vehicles and their trailers by construction, approved by Order No. 2B-479 of 2 December 2008 of the Head of the State Road Transport Inspectorate under the Ministry of Transport and Communications of the Republic of Lithuania).	<ul style="list-style-type: none"> - M1 multi-purpose (AF). - Permissible gross weight - no more than 3.5 t.
2.	Car classification ¹	K3a. Medium vans.
3.	Car production	The car is new, unused, not previously registered, manufactured not earlier than 2026.
4.	Car mileage	Not more than 100 km.
5.	Car color	Black (or equivalent ²).
6.	Color of bumpers and mirrors	Painted body color.
7.	Number of doors	5 (five).
8.	Body	<ul style="list-style-type: none"> - On the right and left sides of the passenger compartment – side sliding doors with glass panes that open and close automatically (electrically). - The rear doors open and close automatically (electrically), with electrically heated glass, rear window washing system and wiper.
9.	Passenger seats	Not less than 1 (driver) + 7 (seven) passenger seats.
10.	Seat layout	<ul style="list-style-type: none"> - 1st row: driver's seat + 1 passenger seat. - 2nd row: 2 passenger seats + 1 folding seat for easier passenger embarkation and disembarkation. - 3rd row: 3 passenger seats.

		- Possibility of easy disassembly and reassembly of 2nd and 3rd row seats.
11.	Vehicle height (with rear doors closed)	Not more than 2050 mm
12.	Car length	Not less than 5300 mm
13.	Gearbox type	Automatic transmission.
14.	Engine type	Plug-in hybrid (PHEV, petrol) or Hybrid (MHEV, petrol).
15.	Average fuel consumption	Not more than 10.5 l / 100 km according to the WLTP methodology.
16.	Engine power, kW	Not less than 140 kW.
17.	Interior heating and ventilation	Heating system and automatic air conditioning in at least 3 zones.
18.	Additional equipment	<ul style="list-style-type: none"> - <i>eco</i> -leather (artificial) or genuine leather, or of a dark (black, gray or similar) fabric, and corresponding trim (recommended by the manufacturer) for other parts of the interior. - Leather-wrapped multifunction steering wheel on the left. - Factory tinting of all glass (according to national standards).
19.	Security equipment	<ul style="list-style-type: none"> - Automatic emergency braking system. - Hands-free system (integrated into the factory sound system). - Acoustic and visual parking system (front and rear sensors). - Factory-installed full-size spare wheel with a steel wheel (jack and tools needed to change the wheel).
20.	Equipment	<ul style="list-style-type: none"> - Electrically operated, heated and folding rear-view mirrors. - Electrically operated front door windows. - Alloy wheels. - Additional set of winter tires. - Remote door unlocking or keyless entry into the car and engine start system. - Factory sound system with speakers, possibility to connect USB storage or wireless connection (<i>Bluetooth</i>). - Adaptive cruise control system. - Additional 12 V passenger compartment at the rear of the cabin.
21.	Eligibility for insurance	Factory alarm and / or immobilizer eligible for CASCO insurance at the Kingdom of Belgium.
22.	Environmental protection requirements	<ul style="list-style-type: none"> - Start-Stop or equivalent function. - CO2 emissions - not less than EURO 6.

23.	Car delivery time	The car must be delivered and handed over in Brussels no later than 4 (four) months from the date of signing the lease agreement, but not earlier than 15/08/2026.
24.	Car kit	<ul style="list-style-type: none"> - Fire extinguisher, emergency sign, necessary instrument kit, first aid kit, two reflective vests and other equipment according to the requirements of the Kingdom of Belgium. - Set of rubber floor mats for the driver and front passenger seats.
25.	Warranty	The car must be covered by a valid manufacturer's warranty for the entire duration of the lease period (36 months).
26.	Ongoing maintenance	The supplier or his authorized representative must provide the service and maintenance specified by the car manufacturer in the car repair shop specified by the seller or his agent in the country of residence of the diplomatic mission, but not less than 15,000 km and not more than once a year (if the service mileage is not reached). The car service must be within 100 km of the diplomatic mission. If the car repair shop is further, the car must be transported and returned at the dealer's expense for service and maintenance.
27.	Documents and registration	Supplier along with the car shall provide all necessary documents, which are the base for Lithuanian diplomatic mission to register the car and get diplomatic plates in the Kingdom of Belgium.
